I. PURPOSE

To specify criteria for determining whether employment leads to "self-sufficiency".

II. DEFINITIONS

DOL - Department of Labor

Full Time Employment - an individual working 40 hours per week, 52 weeks per year.

LLSIL - Lower Living Standard Income Level

Self Sufficiency Wage - An income that covers the current expenditures for the bare necessities for households based on family size. It should include a wage high enough for young families to provide for children, but should not include funds for leisure activities, purchase of luxury goods, savings, purchase of a home, or for higher education.

III. POLICY STATEMENT

The Coastal Bend Workforce Board shall determine and distribute the local self-sufficiency wage levels annually.

The Career Center Service Provider shall have procedures for determining whether employment leads to self-sufficiency.

The Career Center Service Provider shall use current wages earned to determine if a participant meets the self-sufficiency wage levels set by the Board.

- For employed adults employment shall provide not less than the 25th percentile of wages of adults, who have a high school diploma or less, residing in the WDA, aged 25 years and older, and shall be based on full time employment
- For dislocated workers employment shall provide at least 85% of the wage at layoff, or the family income in relation to family size, whichever is higher, but in no event less than the adult self-sufficiency wage
- The special needs of individuals with disabilities or other barriers to employment shall be taken into account when determining self-sufficiency.

The Board's locally determined self-sufficiency wage shall not be lower than 200% of the Lower Living Standard Income and Poverty Income Levels Table published annually by the Texas Workforce Commission.

The Board shall distribute the locally determined self-sufficiency wage table to the Contracted One-Stop Provider each year.

The Career Center Service Provider shall reassess self-sufficiency at least annually.
