## I. PURPOSE:

To ensure that no children of a single military parent or dual military parents in combat deployment have a disruption of child care services or eligibility due to the combat deployment.

## II. **DEFINITIONS**:

*Child*- An individual who meets the general eligibility requirements. A child includes persons born to the parents, persons adopted by either or both parents, the person for whom the parents have legal responsibility granted by the court, or persons provided supervision and care by the parents.

Child Care- Child care services provided by the Board to assist qualified parents who are either working or participating in educational or training activities in accordance with state and federal statutes and regulations.

*Child Care Contractor*-The grant recipient of the funds to implement Child Care Services within the area.

Combat Deployment \_- The deployment to military combat away from the home base of the singe military parent or the dual military parents of an eligible child enrolled in child care services. This includes deployed parents in the regular military, military reserves, or National Guard.

Dual Military – Both parents are in the regular military, military reserve, or national guard.

*Parent* (s)— Individual(s) responsible for the care and supervision of the child identified as the child' natural parent, adoptive parent, stepparent, or legal guardian.

Single Military Parent – An individual that is a single parent and is in the regular military, military reserve or national guard.

## III. POLICY STATEMENT:

The Contractor shall ensure that no children of military parents in combat deployment have a disruption of child care services or eligibility due to the combat deployment.

The parent's share of cost during the combat deployment will be frozen.
